

Domestic Travel Terms and Conditions (Summary)

This tour is offered by IWATE KAIHATSU SANGYO Co., Ltd. (Iwate Kaihatsu Kanko, Iwate Prefectural Governor Registered Travel Agency No. 2-50, hereinafter referred to as "the Company"), and the contract for the organized tour (hereinafter referred to as "the Contract") between the customer participating in this tour and the Company shall be governed by the provisions of these General Terms and Conditions. Matters not stipulated in these general terms and conditions shall be in accordance with laws and ordinances or generally established customs. The contents and conditions of the Contract shall be in accordance with the conditions stated for each course, as well as the conditions stated in the "Final Itinerary" and the Company's travel conditions document, which will be delivered prior to departure.

Handling of personal information

- (1) The Company and its sales agents will use personal information provided on the application form prior or during the course of the tour to communicate with the customer, and use personal information to the extent necessary for the arrangement of services provided by transportation and accommodation agencies, etc. for the tour for which the customer has applied, and to the extent necessary for the procedures for receiving such services. In addition, we will provide personal information to the transportation/accommodation agency, insurance company, souvenir store, etc. to the extent necessary for the procedures to arrange and receive the services provided by the transportation/accommodation agency, etc. for the trip you have applied for, to the extent necessary for the procedures for insurance to cover our liability under the travel contract and expenses in case of accident, and to the extent necessary for the convenience of your shopping at the souvenir store of the travel destination. Personal information such as name, etc. of the customer will be provided to such transportation and lodging agencies, insurance companies, souvenir shops, etc. by electronic means in advance. When you apply for the service, you shall consent to the provision of such personal data.
- (2) We may ask for personal information of your emergency contact person during your stay in case of illness or accident during the tour. This personal information will be used only in the event of illness, etc., and when the Company deems it necessary to contact the emergency contact person.

We deem that you have obtained consent of your emergency contact to provide the Company their personal information.

Application for the tour and entering the Contract...

Please fill out the prescribed items on the application form and submit it with the application fee. The application fee will be handled as part of the tour fee or cancellation/penalty charges.

- (1) The Company accepts tour reservations by telephone, mail, facsimile, or other means of communication (hereinafter referred to as "telephone, etc."). In this case, an application form and application fee must be submitted within 3 days from the day following the day on which the Company has been notified of the acceptance of the reservation. If the application form and application fee are not submitted within this period, the Company will treat the reservation as not having been made.
- (2) The Contract shall be in effect once the Company approves the customer to enter the Contract and the application fee is received.
- (3) Application fee (per person) Application Fee for Travel Cost less than 30,000 yen will be 6,000 yen. Travel Cost less than 60,000 yen will be 12,000 yen, Travel Cost less than 100,000 yen will be 20,000 yen, Travel Cost less than 150,000 yen will be 30,000 yen. Application Fee for Travel Cost greater than 150,000 yen will 20% of Travel Cost.

Payment of the tour fee...

The customer shall pay the Company the amount of the tour fee stated in the contract document by the date stated in the contract document on or before the commencement date of the tour.

- (1) The tour fee includes transportation fares and charges (economy class unless otherwise noted), lodging(day trip not included), meals, entrance fees, planning and handling fees, and consumption tax. (2) Expenses not specified in the itinerary, notes, and personal expenses are not included.

Cancellation Fee...

①Cancellation on or before the 21st day prior to the start of the tour (the 11th day in the case of a one-day tour)...free of charge ②Cancellation on or after the 20th day (the 10th day in the case of a one-day tour / except in the cases listed in ③ through ⑥)...20% of the tour fee ③Cancellation on or after the 7th day (except in the cases listed in ④ through ⑥)...30%of the tour fee ④Cancellation 1 day before the start of the tour...40% of the tour fee ⑤In case of cancellation on the day of the start of the tour (except in the case of ⑥)...50% of the tour fee ⑥In case of cancellation after the start of the tour or no-show without notice...100% of the tour fee

Cancellation of the tour...

In the event that the number of participants is less than the minimum number specified for the tour or in any other case, the Company will notify you that the tour will not go on 14 days (4 days for day trip) prior to the departure date of the tour. In addition, the Company may cancel the tour in the event that the safe and smooth implementation of the itinerary described in the Contract is impossible or highly unlikely to be implemented due to an order issued by a government, public office or other reasons beyond the

Company's control.

The final itinerary will be sent 10 days prior to the departure date of each tour with information such as the place and time of boarding.

All prices listed include taxes.

The plan for domestic commissioned sales and overseas travel planning and commissioned sales shall be in accordance with the terms and conditions of each travel agency.
